# **Job Description Play Worker**

**Responsible to:** The position works under the direction of the Teachers, and is accountable through the College to the Board of Trustees.

**Hours**: 4.66 hours per week for the approx. term-time only for the approx. 36 weeks of our academic year.

- Lunch Break Supervision 1.40 2.00pm Monday to Friday
- Afternoon Play Based Sessions 2.00-3.30pm Monday <u>and</u> Friday

**Salary**: £8.72 per hour plus statutory holiday pay (equivalent to £9.77 per hour) term-time only (This post is <u>not</u> eligible for the School's Staff Discount scheme on School fees)

Type: Fixed Term to 9 July 2021

### Main responsibilities of the post:

The primary focus of this post is to plan, organise and lead play-based Afternoon sessions for a Class of children aged 6 to 8. The role will also assist the Teachers on lunch break supervision.

#### **SAIS Session leader**

- To plan, organise and lead play-based Afternoon sessions for a Class aged 6 to 8
- To use play activities to help the children to develop socially and emotionally
- To set up and put away play equipment and make sure play areas are safe
- To encourage children to be aware of their own safety and that of others
- To supervise children for fair behaviour during play, dealing with any minor injuries
- To encourage fair and caring behaviour among the children
- To encourage independence and self-esteem

### **Break Duty**

- To assist the supervision all classes during lunch break both inside and outside.
- To be observant, engaged and creative with the children, helping them engage in active but positive and responsible play.
- To work with the Teachers to support and encourage positive behaviour and expectations in the playground.
- To ensure, through observation and monitoring, that pupils are safe inside and outside the school building
- To be aware of daily risk assessments and records of the school playground. To observe for and remove any hazards from the playground. To rectify any risks immediately, or if this is not possible to report the risk to the School Administrator immediately.
- To deal with any minor injuries and ensure that any major injuries or sickness of pupils is reported immediately to the teacher on duty and School Administrator or School Office. To enter all required injuries in the accident book and report them to the pupil's Class Teacher/ Guardian.
- To deal on the spot with pupils who break the behaviour guidelines using the School's procedures. To deal with incidences including unruly or unsocial behaviour by pupils where appropriate, to report more serious incidences immediately to the Class Teacher on duty. To

record all incidences following the School's policies and procedures and to report them to the pupil's Class Teacher/ Guardian.

#### Other duties

- To work within the teaching group to ensure the smooth day-to-day running of the whole School as required.
- To cover in Teachers' and other colleagues' absence where required.
- To be willing to learn about Steiner Waldorf Education and undertake appropriate preparation, study and training as necessary.
- To attend meetings as required.
- To take part in the appraisal of your own work performance.
- To support the School's ethos, principles and objectives.
- To be aware of and comply with the School's policies and procedures and to support their implementation including the Safeguarding and Health and Safety policies.

The above list is not exclusive or exhaustive and the post holder will be required to undertake such duties as may reasonably be expected within the scope of the post. All members of staff are required to be professional, co-operative and flexible and undergo reasonable and directed professional development. This may require out of 'normal hours' personal study which may be unpaid.

- A sound track record of supporting children's play, including children with additional learning or behavioural needs
- The ability to lead and support inclusive, safe and creative play incorporating the play principles of Steiner Waldorf education (guidance can be provided on this)
- The ability and experience to lead a group of children on your own
- The ability to engage, inspire and support children
- A commitment to the ethos of our School
- An understanding of the Steiner-Waldorf approach to play and / or a willingness to learn and develop your practice
- A demonstrable commitment to effective professional development and ongoing learning
- A flexible, cooperative and positive approach to work
- Personal warmth, patience, respect and understanding
- Good organisational skills and a strong sense of responsibility
- Excellent communication skills with children, parents and colleagues
- Proven ability to work in a small, close knit team
- Excellent punctuality and time-keeping skills
- Suitability to work with children and willingness to undertake an Enhanced DBS disclosure;
